

**Digital Imagery Juried Exhibition February 12-March 12, 2010**  
**Digital Imagery Installation Huston Gallery, CCAA West Chester**  
**Opening Reception: Feb. 11, 5 – 8 p.m.**

**What is it?:** This installation is a collaboration of Chester County Art Association (CCAA) and Chester County Camera Club (CCCC). Images will be projected onto a blank wall in rapid succession, with two projections running simultaneously. This installation will enable public viewing and exposure of local artists' work. Images will also be viewable online in a special Zenfolio.com album. No physical images will be seen at the Huston Gallery.

Open to members of CCAA and CCCC, and non-members of either organization.

**All images will be sold at \$40 per image.**

Each artist will **receive \$16 commission per sold work**, which will be the remainder after Zenfolio.com and CCAA fees are paid.

Prints will be produced and sent from Zenfolio directly to the customer.

**Requirements:**

Artists are invited to submit a maximum of **five (5) digital images**. Images should be:

- **jpeg** format (.jpg)
- **~300 dpi** (no less than 250 dpi for printing purposes, no more than 300 dpi necessary) sized to match artist's chosen printed image size of:  
**8x10, 8x12, or 11x14 one size per image.**
- file should be named "SubmissionNumber\_Title\_LastName\_Size.jpg"  
i.e., artist's third and fourth of five entries would be called:  
**"3\_HiddenWaterfall\_Smith\_8x12.jpg,"**  
**"4\_EasterFlower\_Smith\_11x14.jpg"**

**Submitting:**

Artist should send **ONE** single email to: [CCAAdigitalimagery@gmail.com](mailto:CCAAdigitalimagery@gmail.com).

- Subject line should be: "CCAA digital images – YourLastName."
- Email content should include: full name, address, phone number, email address, number of entries, and note whether CCAA member, CCCC member, both CCAA/CCCCA member, or member of neither.
- Attach up to five jpeg images with file names as specified
- \$20 entry fee for members of either/both CCAA or CCCC, \$25 for non-members. Entry fee can be mailed in or dropped off to CCAA, 100 N. Bradford Ave., West Chester, PA 19382, by Friday, January 29, 2010, in the form of cash or check.
